- the performance, the communication to the public, and the distribution by means of physical magazines and publications, posters, etc., and the publication on telematic networks such as the Internet, or by any technical means that allow for the use of the work, television broadcasting, digital satellite television, etc., as well as for use in conventions and related events for cultural, promotional or didactic purposes, and any other use permitted by law, without commercial purposes;
- the filming of the minor in video, audio and photographic recordings, or other audio-visual materials containing his/her image, name and/or voice, during the course of the activities organised within the framework of the International Competition *Premio Roma Danza 2025*, giving full consent to the possible broadcasting and/or publication of the same on the website of the Accademia Nazionale di Danza, as well as on other authorised websites, in print and in newspapers, at seminars, conventions, conferences, shows, etc., to be used exclusively for the purposes of information, communication, publicity, promotion, valorisation and documentation of the event and the activities carried out;
- the preservation of the works presented in the digital archives of the Accademia Nazionale di Danza.

In view of the above, the undersigned declares that he/she will not have any claims against the Accademia Nazionale di Danza, now or in the future, in any capacity whatsoever, for any use of the minor's image and the work entered in the competition, without prejudice to the authors indicated.

Finally, the undersigned declares that he/she has read and fully accepts the conditions contained in the public announcement of the *Premio Roma Danza 2025*.

The present authorisation does not permit the use of images in any context which may compromise personal dignity or the propriety of minors or for any usage or purposes other than those indicated above.

The undersigned confirms to have no claims in respect to that indicated above and irrevocably renounces any rights, actions or claims deriving from that which is authorised above.

In no case will claims of indemnification by third parties for eventual moral or material damages caused by or derived from usage not foreseen in the present waiver be brought forth.
